

The LeadingAge Iowa Assisted Living Nurse Delegation course is formatted to help attendees manage their time while still receiving quality training and networking with colleagues. LAI recognizes that people want more options when it comes to training delivery models. **The live session will be available for attendees to register for either in-person in a traditional classroom model or in a live-streaming, virtual zoom setting.**

### PROGRAM DESCRIPTION

This class meets Iowa Assisted Living Regulation: 481-69.29(6): All programs employing a new delegating nurse after Jan. 1, 2010, shall require the delegating nurse within six months of hire to complete an assisted living manager class or assisted living nursing class whose curriculum includes at least six hours of training specifically related to Iowa rules and laws on assisted living. A minimum of one delegating nurse from each program must complete the training. If there are multiple delegating nurses and only one delegating nurse completes the training, the delegating nurse who completes the training shall train the other delegating nurses in the Iowa rules and laws on assisted living. As of Jan. 1, 2011, all programs shall have a minimum of one delegating nurse who has completed the training described in this subrule. The live training session will be available as either in-person in a traditional classroom model or in a live-streaming, virtual zoom setting.

Knowing the regulations and understanding the monitoring process will assist in maintaining a focus on quality tenant services. A review of what to expect during this process and the documentation needed to be successful will be held.

**Medication Management** (Julie Johnson, Healthcare of Iowa)

During this presentation, we will cover medication management in assisted living. We will also cover high risk medications, why they are high risk medications, and what you need to be aware of when tenants are receiving high risk medications.

**Nurse Delegation and its Use in Assisted Living** (Julie Johnson, Healthcare of Iowa)

Nurse delegation and its use in assisted living will be reviewed. The role of the assisted living nurse and direct care worker will be presented and how delegation can be used effectively.

3:15 – 4:30 p.m.

**Philosophy of Assisted Living** (Kellie Van Ree, LeadingAge Iowa)

This session will discuss the philosophy and background of assisted living. The principles of assisted living will be reviewed along with a comparison of assisted living to other residential programs. The basic concepts of choice, independence, privacy, individuality, and dignity will be discussed.

**Survey Trends** (Kellie Van Ree, LeadingAge Iowa)

This session will review the most commonly cited insufficiencies of assisted living programs. Best practices for successful surveys will also be discussed.

### CONTINUING EDUCATION CREDIT

**Iowa Board of Nursing Provider #67** – 7 contact hours. Providership regulations do not allow for partial credit to be given for any portion of this program. You must attend the entire program to receive credit. Retain certificate for four years.

**Assisted Living Recertification** - 7 contact hours toward continuing education for maintaining Assisted Living Leadership Certification for attending the entire event.

**Nursing Home Administrators** – 7 contact hours will be awarded for attendance at the entire event. This program is intended to meet the criteria established by the Iowa Board of Examiners for Nursing Home Administrators. You must attend the entire program to receive credit. No partial credit allowed. If audited, you will be asked to provide your certificate of attendance and program material. Retain certificate for four years.
